I, Vijay J Bhatt. Proprietor of Vijay Bhatt & Co. - 2. The Compliance with the provisions of the Companies Act, 2013 and the Rules made there under relating to e-voting (which includes remote e-voting and the electronic voting, provided at the AGM) to the Members on the Resolutions proposed in the Notice calling the 54th AGM of the Company is the responsibility of the management.
